### **Terms and Conditions for International Online Learners**

International learners who (for unavoidable reasons), may be permitted to study an alternative curriculum while at Purpose college under the following conditions:

1. Parents/sponsors of international learners utilizing an alternative curriculum provider will be billed 50% of Purpose College school fees and full stationery costs, as seen below. This fee covers their child's space on the premises, internet, and supervision.
2. The parents/sponsors acknowledge and accept that all school fees must be paid into the Purpose College account (see below), and not the Healing Wings account. Account queries must be forwarded to [accounts@purposecollege.co.za](mailto:accounts@purposecollege.co.za)
3. The parents/sponsors acknowledge and accept that Healing Wings admission policy states that all children are required to attend school whilst in treatment. This is non-negotiable and should the parents/sponsors wish their child take a sabbatical from school, their child will not be admitted into/remain in the Healing Wings program.
4. The parents/sponsors acknowledge and accept that Purpose College will not manage any administration, logistics, teaching, or other matters of any external schooling. The parents/sponsors must arrange a suitable school and handle all communication etc.
5. The parents/sponsors acknowledge and accept that Purpose College holds no liability for any problems that may arise from any chosen online school/schooling and such problems will not be placed onto Purpose College and or its staff, to resolve.
6. The parents/sponsors must supply their child with his/her own Windows laptop (not Mac), laptop bag, and school bag. We do suggest that parents provide their child with a separate internet dongle with loaded data to use during loadshedding or power outages during storms.

- School fees indicated here are already calculated at 50% of Purpose College full fees.
- Stationery fees are charged at full cost – must be paid immediately.

- Educational fees are separate from therapeutic/tuck shop fees and **must** be paid into the Purpose College bank account, listed below.
- Invoices are sent on the 1<sup>st</sup> of each month for the following month. Payment is due before the end of the month in which the invoice was sent.  
(le March invoice will be sent on the 1<sup>st</sup> February and is payable before the 1<sup>st</sup> March.)
- Statements are also sent out on the 1<sup>st</sup> of each month.
- Payment for the first full invoice must be received on or before the day of admission to Healing Wings (even if the child arrives during school holidays).
- School fees are calculated per term but can be paid over 11 months, per term, or per year.
- All educational fees are the responsibility of the sponsor/acountholder.
- Additional unforeseen costs (including but not limited to damage to property, breakages) will be billed to and covered by the sponsor/acountholder.
- 10% interest will be charged for accounts past 60 days overdue.
- Accounts past 90 days overdue will be handed over for collection without notice.
- Legal fees will be added to outstanding amounts.
- Fees are payable in advance, are non-refundable, and should the learner leave for any reason whatsoever (including but not limited to absconding – see below – or expulsion) prior to the program being completed, no monies are liable to be refunded. Purpose College reserves the right to claim recovery of any amount still outstanding, notwithstanding the early termination thereof.
- Leaving prior to the completion of a program period constitutes as absconding and all related school fees will be forfeited.
- In the event the learner is not committing to their education, the fees are still payable.
